Subject: Maintaining your FEMA Instructor

You are receiving this General Memo (GM) because you are an existing or new FEMA instructor. FEMA has finally implemented the CEU process for maintaining your FEMA instructor certification. This GM outlines the procedures that need to be followed in order to maintain your instructor status.

You have 36 months to complete CEU's in your FEMA instructor discipline. If you hold multiple instructor disciplines, you will need to obtain CEU's for EACH discipline you hold. For any new instructors, your start date is 6/26/23, any instructors before 2023, your start date is 5/21/23. That means everyone is due in 2026. If you do not complete your CEU's, your FEMA instructor will lapse and you will not be authorized to teach in that discipline.

Top right-hand corner says "Instructor Management" (By your name)

When you click on it you will see your FEMA instructor number and existing authorized instructorship disciplines.

You will upload into ESF9. Under the instructorship it shows a tab that says "Manage CEU"
